# FAMILY FUN CRUISES & TOURS

## INDEPENDENT CONTRACTOR TRAVEL AGENT AGREEMENT

**I WILL SUPPORT THE TRAVEL INDUSTRY AND FAMILY FUN CRUISES BY PROMOTING, GENERATING, AND CREATING TRAVEL SALES FOR THE DURATION OF THIS AGREEMENT. I SHALL BE AUTHORIZED TO ACT AS AN INDEPENDENT TRAVEL AGENT FOR FAMILY FUN CRUISES. I SHALL BE FREE TO MARKET TRAVEL AS I WISH, PROVIDED I ACT PROFESSIONALLY, AND IN THE BEST INTEREST OF THE TRAVEL INDUSTRY.**

FAMILY FUN CRUISES SHALL PAY TO ME, NOT AS SALARY OR WAGES, BUT AS MY SHARE OF THE COMMISSIONS RECEIVED BY FAMILY FUN CRUISES. I WILL RECEIVE **60% OF ALL COMMISSIONS DUE ME FOR TOUR AND CRUISE BOOKINGS AND 50% FOR AIR, CAR RENTALS AND HOTELS, LESS POSTAGE FEES. COMMISSIONS ARE NOT PAYABLE TO AGENT IF A COMMISSION REQUEST FORM HAS NOT BEEN SUBMITTED WITHIN SIX MONTHS OF ORIGINAL BOOKING DATE.** I WILL ALSO BE ELIGIBLE FOR SPECIAL TRAVEL OPPORTUNITIES AND PRICES, AS OFFERED FROM TIME TO TIME. I UNDERSTAND THAT BENEFITS OFFERED BY TRAVEL VENDORS TO THE TRAVEL AGENCY COMMUNITY ARE DISCRETIONARY PRIVILEGES. **I AM NOT APPLYING TO THIS NETWORK SOLELY TO OBTAIN SUCH BENEFITS.** THIS AGREEMENT WILL BECOME BINDING AND EFFECTIVE UPON PAYMENT OF NETWORK FEE. THE AGREEMENT MAY BE RENEWED THEREAFTER ON AN ANNUAL BASIS IF I HAVE PAID MY APPLICABLE RENEWAL FEE. I MAY NOT ASSIGN THIS AGREEMENT. THIS AGREEMENT DOES NOT CONSTITUTE THE SALE OF A FRANCHISE OR DISTRIBUTORSHIP. MY SIGNATURE ON THIS AGREEMENT INDICATES MY ACCEPTANCE OF THIS AGREEMENT. I SHALL BE AN INDEPENDENT CONTRACTOR AND NOT AN EMPLOYEE OF FAMILY FUN CRUISES. I SHALL BE RESPONSIBLE FOR ANY AND ALL TAXES, EXPENSES, AND OTHER PAYMENTS ARISING FROM MY INCOME AND THE ACTIVITIES I CONDUCT UNDER THIS AGREEMENT. I WILL NOT BE AN EMPLOYEE OF FAMILY FUN CRUISES AND WILL BE TREATED AS A NON-EMPLOYEE REGARDING ALL LAWS COVERING EMPLOYEES INCLUDING, BUT NOT LIMITED TO, THE FEDERAL INSURANCE CONTRIBUTIONS ACT. THE SOCIAL SECURITY ACT, THE FEDERAL UNEMPLOYMENT TAX ACT, INCOME TAX WITHHOLDING AT ANY SOURCE AND ANY OTHER STATE OR FEDERAL LAWS. I AM RESPONSIBLE TO OBTAIN ANY BUSINESS OR OTHER PERMITS REQUIRED BY LAW RELATING TO THE OPERATION OF MY INDEPENDENT TRAVEL BUSINESS, AND I WILL COMPLY WITH ALL APPLICABLE LAWS. THE LAWS OF THE STATE OF NEW YORK SHALL GOVERN THIS AGREEMENT. I WILL ABIDE BY ALL FEDERAL, STATE, COUNTY AND LOCAL LAWS, RULES AND REGULATIONS PERTAINING TO THIS AGREEMENT. FAMILY FUN CRUISES AND RUBEN MUNIZ NEITHER GUARANTEES NOR INSURES THE SERVICES PROVIDED BY ANY OFFICER, EMPLOYEE OR MEMBER AND SHALL ASSUME NO RESPONSIBILITY FOR ACTIONS BEYOND ITS OWN CONTROL IN CONNECTION WITH SERVICES PROVIDED. FAMILY FUN CRUISES AND RUBEN MUNIZ IS NOT RESPONSIBLE FOR ANY ACT, ERROR, OMISSION, INJURY, LOSS, ACCIDENT, NONPERFORMANCE, OR ANY OTHER IRREGULARITY, OR ANY CONSEQUENCES RESULTING THEREFROM, WHICH MAY BE OCCASIONAL THROUGH, NEGLIGENCE, DEFAULT, OR ANY OTHER ACTION OF ASSOCIATION/COMPANY, CARRIER, OR PERSON ENGAGED IN THE SERVICE OF FAMILY FUN CRUISES OR RUBEN MUNIZ. MEMBER FEES ARE NON-REFUNDABLE AND NON-TRANSFERRABLE. RENEWAL FEES ARE SUBJECT TO CHANGE. A COPY OF THIS AGREEMENT HAS BEEN GIVEN TO ME AND I AGREE TO COMPLY WITH ITS TERMS BY SIGNING AND DATING THIS INDEPENDENT CONTRACTOR TRAVEL AGENT AGREEMENT.
